This waiver is designed around mandates set forth by the state of Kansas and Johnson County Department of Health. Woodsonia wants to make sure that all residents adhere to this guidance. We want to make sure all residents feel safe when enjoying the Woodsonia Pool this summer. Please fill out this waiver for your family if you would like to have access to the pool for 2021. \*All Parts (even email) must be filled out in its entirety. Failure to do so will result in your pool key not being activated and denied access to the pool. One waiver per household needs to be on file before your pool key will be activated for the 2021 pool season.

Please read and check each box, and sign at the bottom of this waiver.

- I understand that I must be current on all dues.
- I acknowledge that the pool is under video surveillance and my family will be recorded.
- I understand an Adult, 18 or older must accompany all children under the age of 14.
- I understand that the CDC states I must abide by the 6-foot social distance from others (except those in my household).
- I understand that I may not come to the pool if I am sick.
- I understand that Woodsonia and all its residents are not liable should I (or anyone in my household) become sick with any communicable disease.
- I will practice good hand washing. I understand that the pool will be cleaned in the morning, and that I am responsible for bringing my own disinfectant wipes if I need them.
- I understand that swim diapers must be worn if children aren't potty trained.
- I understand that under Johnson County guidelines, I must shower before coming to the pool.
- I understand that the current head count allowed for the Woodsonia pool is **37** people max at a time, but that it may change at any time.
- I understand that Johnson County Health Department will be monitoring the amount of people at the Woodsonia pool, and a fine will be given if the number exceeds the current order.
- We will keep the gate to the pool enclosure closed at all times.
- No smoking or vaping within the pool enclosure.
- No glass containers allowed in the pool enclosure.
- I understand no food or drink is allowed in the pool or the pool deck within 4 ft of the water.

- I understand that **NO** flotation devices (rafts, inter-tubes, etc.) are allowed at the pool. No balloons of any kind allowed in the pool enclosure. (Infant or toddler devices **ARE** allowed)
- I understand the HOA has the right to change the pool rules at anytime.
- I understand that the HOA Board has the authority to turn off my pool key for not abiding by the rules, or shut down the pool at any time, for any reason.

I understand that it is my responsibility as a Woodsonia homeowner to call the non-emergency number (913-631-2155) if I witness any of the following:

- Trespassing this includes but not limited to jumping the fence, entering the pool without a key
- Vandalism
- Suspicious behavior

I agree to the terms of this waiver and breaking any part of this agreement will result in automatic loss of all pool privileges for the 2021 season.
